

## The Emergency Income – REM

It's an extraordinary support measure to the income called Emergency Income ("REM"), bound to household who lives conditions of economic necessity as a consequence of the COVID-19 disease, as envisaged by the Art.82 of the Decree-Law No. 34 of 19 may 2020.

Applications shall be submitted within the June 30th 2020 to INPS, logging in with PIN, SPID, National Services Card or Electronic ID Card, or by INAS CISL Welfare Office.

The economic support is provided for two months. The monthly fee of 400 € could reach to 800 € based on the number of family members.

*If in the household there is a severely disabled or non-autonomous member, the REM maximum amount can reach 840 €.*

### Requirements:

- residency in Italy;
- the household has:
  - an ISEE below 15.000 €;
  - movable property (to 31.12.2019) below 10.000€ (to a maximum of 20.000€ according to the household and to € 25.000 if there is a severely disabled or non-autonomous member);
  - family income value, in the month of april 2020, below the due REM amount

The persons who are in prison, for all the length of their sentence, and the persons who are admitted to long term care institutions or other residential facilities at the total expense of the State or other public administration, are not eligible for REM.

In case of the beneficiary household has among their members persons who are in one of the case listed above, they will not be counted for the calculation of the amount.

REM is not compatible with the presence in the household of persons who:

- receive direct or indirect pension, except the disability check;
- receive the citizenship income or pension;
- has an employment contract with a gross salary exceeding the due REM.

Are not entitled to reach REM the household with workers who perceive or have perceived allowance from COVID-19 disease who are in one of the following categories:

- ✓ self-employed workers enrolled in the INPS management
- ✓ self-employed workers registered for VAT enrolled in the Separate Management
- ✓ Workers who has a coordinated and continuous collaboration enrolled in the Separate Management
- ✓ seasonal workers of tourism and thermal baths
- ✓ workers in the entertainment industry
- ✓ agricultural workers
- ✓ seasonal workers of different sectors to tourism and thermal bath
- ✓ intermittent workers
- ✓ Self-employed workers, without VAT, not enrolled in other mandatory social security forms
- ✓ Doorstep selling workers
- ✓ domestic workers.
