

Emergency Income-REM

The Emergency income (REM – Reddito di Emergenza) is an economic support measure established with [article 82 of the decree-law of 19 May 2020, n. 34](#) in favor of families in difficulty due to the epidemiological emergency from Covid-19. The support decree ([d.l. 41/2021](#)) extends the measure for the months of March, April and May 2021.

Applications must be submitted from 7 to 30 April 2021 to INPS, authenticating on the site via PIN, SPID, National Service Card or Electronic Identity Card, **or to the Inas Cisl Patronage**.

The monthly amount amounts to a minimum of € 400 and can reach € 800, depending on the number of family members.

In the event that there is a serious disabled or non-self-sufficient member in the family unit, the maximum amount of the Rem is raised to € 840.

Requirements required:

- residence in Italy;
- having a value of family income, in February 2021, lower than the REM amount (for those who reside in a rented house, the threshold is increased by 1/12 of the annual value of the rent, indicated on the ISEE);
- a value of family movable assets, referred to 31.12.2020, (bank or postal deposits, government bonds and everything indicated on the Isee model) below a threshold of € 10.000, increased by € 5.000 for each component following the first and up to a maximum of 20.000 euros (the maximal

is increased by a further 5.000 euros, in the event of the presence in the family unit of a member in a condition of serious disability or non self-sufficiency);

–an ISEE value, certified by the DSU and valid at the time of submitting the application, of less than 15.000 euros.

Incompatibility:

- with COVID-19 allowances for seasonal workers in tourism, spas, entertainment and sports;
- with retirement benefits, direct or indirect, except for ordinary disability support and civil disability treatments;
- with income from employment, whose total gross salary is higher than the maximum family income threshold, identified in relation to the composition of the nucleus;
- with the Income and Citizenship Pension (Reddito e Pensione di cittadinanza) received at the time of the application.

REM for workers at the end of unemployment benefits

The benefit is accessible to workers (residing in Italy at the time of submission of the application) who have finished receiving NASpI and DIS-COLL between 1 July 2020 and 28 February 2021, and have an Equivalent Economic Situation Indicator (ISEE) valid, ordinary or current, not exceeding 30.000 euros.

Incompatibility:

- use of one of the COVID-19 allowances for seasonal workers in tourism, spas, entertainment and sports;
- on the date of March 23rd, 2021, beneficiary of direct or indirect retirement benefit, except for ordinary disability support and civil disability treatments;
- on the date of March 23rd, 2021, holder of an employment contract, except for intermittent employment contract without the right to the availability allowance, or of a coordinated and continued collaboration contract;

Furthermore, the payment of the Rem is incompatible with the collection, in relation to the same period, of the income or the citizenship pension (reddito o pensione di cittadinanza).
